ADVOCACY

Our advocacy efforts to educate lawmakers and the public about our profession focus on Medicaid funding, certificate of need laws, medical malpractice laws and much more. We advocate on your behalf with legislators in Raleigh and maintain strong relationships with the Department of Health and Human Services. We work closely with the American Health Care Association to represent our members' interests in Washington, D.C. and at the Centers for Medicare & Medicaid Services. We also represent members' interests on statewide boards, committees, task forces, and work groups.

We offer guidance to members on Medicare, Medicaid, CMS Requirements of Participation, NC Licensure, Five-Star, and Workforce.

ANNUAL AWARDS PROGRAM

The NCHCFA Annual Awards Program honors frontline skilled nursing facility personnel who have demonstrated outstanding achievements. A panel of judges from the Education and Programs Committee selects one nominee from each of the five districts in NC to receive the "Nurse Aide of the Year" award and one recipient in a non-nursing discipline to receive the "Riley W. Clapp Outstanding Service" award.

LEADERSHIP DEVELOPMENT

NCHCFA offers leadership training through our Institute for LTC Leaders program. This is an intensive, interactive experience that is open to emerging leaders within NCHCFA and the profession. The application period opens in November and the Institute's programming runs from January to December the following year.
