NCHCFA/PAC fundraising launched in February 2023, and we greatly appreciate all members who participated.

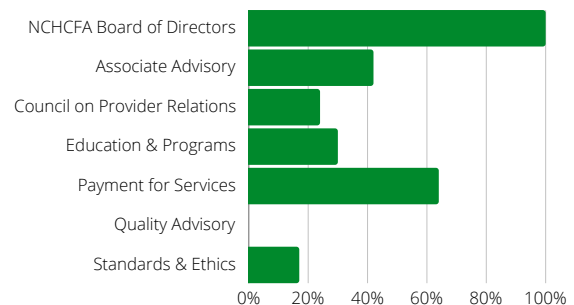
At the close of another challenging year, we are pleased to report that our 2023 fundraising efforts exceeded our goal and totaled \$195,595.

NCHCFA/PAC donates to Democrat and Republican political races across the state. All distributions are approved by the NCHCFA/PAC Committee, comprised of five members selected by the NCHCFA Board of Directors Chair.



We support candidates based on their proven record of supporting issues that promote our priorities; their position in the General Assembly or influence with the elected leadership of the House or Senate; and their willingness to fight on our behalf, among other things.

NCHCFA/PAC is a political committee whose mission is to support NCHCFA members by providing contributions and education to candidates for statewide elected office (Council of State) and seats in the General Assembly who promote the value and needs of the post-acute and long term care community in North Carolina.
